I need only mention a few programs to illustrate how vibrant your work has been.

 The CLE Committee has provided outstanding programs and has more planned for the New Year, including a joint session with the Virginia Beach Bar Association.

- The Courts of Justice Committee has met and is committed to ensuring that Norfolk gets a new courthouse complex that justice and public safety require. The chief judges of each of the Norfolk courts have taken the bold move of writing a joint letter to the Mayor, City Council, and the City Manager to make the argument for urgent attention to our obsolete and unsafe Norfolk court facilities. We have published their letter in this bulletin. The letter received attention in an article in *The Virginian-Pilot* and we have written a letter to the editor supporting the judges and urging the implementation of a plan to achieve the construction of a new court complex that will meet the needs of the 21st century in Norfolk and Hampton Roads (the Norfolk courts serve a wider constituency than just Norfolk criminals ignore jurisdictional boundaries and civil matters likewise cross city, county, and even state boundaries).
- The Young Lawyers Section has conducted a number of events that bring the bar together and continues with plans for 2007. The "Breakfasts with the Bench" are a big hit.
- The **Professionalism Committee** will be working on selecting the recipient of the Eggleston-I'Anson Professionalism Award and will need your nominations of worthy attorneys who have made exceptional contributions to the profession over a significant period of time.
- The Public Relations Committee will soon be seeking nominations for the Walter E. Hoffman Community Service Award that recognizes outstanding service to the community by a younger NPBA member. They will also be sponsoring our Annual Food Frenzy for the benefit of the Southeastern Virginia Foodbank. Virginia AG Bob McDonnell was so impressed with our program, he convinced the VBA to go statewide with it. The PR Committee is again sponsoring the Model Judiciary Program in four Norfolk middle schools. The program will begin in early January with mock trials to be held in March in Norfolk Circuit Court.
- The NPBA Foundation has made great strides in obtaining commitments from many of you (much more work to do in fund raising) and is planning as a joint venture with Regent University to produce a "Law School for Journalists" program on April 20th.

There will be many special programs during the visit of these seminal documents. KEYNOTE SPEAKER: FORMER GOVERNOR MARK R. WARNER



Mark Warner was born in Indianapolis, Indiana in 1954. He earned his undergraduate degree from George Washington University in 1977 and his law degree from Harvard University

in 1980. He is married to Lisa Collis and they have three daughters. Warner served as Governor from 2002-2006. His administration inherited \$6 billion in budget shortfalls and ended with a surplus that allowed investments in education, care for Virginia's most vulnerable citizens and Chesapeake Bay

cleanup. Warner did this by cutting budgets, finding efficiencies and making business-like reforms. He took on modernization of Virginia's tax code to promote fairness, long-term fiscal integrity and the preservation of core services. He was named among Governing Magazine's "Public Officials of the Year," TIME Magazine's "America's 5 Best Governors" and Newsweek's "Who's Next" issue in 2006. Warner serves as Honorary Chair of Forward Together, whose mission is to recruit and elect a new generation of leaders across America.

LETTER FROM NORFOLK COURTS REGARDING COURTHOUSE CONDITIONS

Dear Mayor Fraim and Members of the City Council:

For two decades the three trial courts for Norfolk – the Circuit Court, General District Court, and Juvenile and Domestic Relations District Court – have described the security needs of the city's three courthouses. During the past several years the City has engaged in a thorough examination of the needs of these facilities and has involved the judges of these courts in the process. As a result of these studies, the Council and administration concluded that all of the courthouse facilities are inadequate and sought architectural proposals some two years ago for construction of a new facility. At some point thereafter the City turned its attention to exploring public-private partnership options for the construction of a new courthouse to serve the three courts.

We, speaking for all of the judges of our respective courts, now feel compelled to express our collective conclusions about the needs of our courthouses and the immediacy of the need to give better protection to the citizens who enter these buildings. We are concerned that the real danger existing in these buildings may not be fully appreciated. In our view, the safety of each person who enters one of Norfolk's courthouses is in danger.

The problems identified in a 1992 study by the National Center for State Courts continue to plague our facilities: circulation patterns, security, prisoner access and holding areas, and insufficient waiting areas. The difference today when compared to 1992 is that the severity of the problems has seen a dramatic increase and a consequent growth of danger for those using the courthouse facilities.

After years of discussion, study, and planning, the courthouses remain inadequate. In their present conditions, they are unsafe for the public. Overcrowding, lack of safe circulation patterns, buildings that do not and cannot meet current safety and security standards – all those concerns so well documented over the past two decades – still characterize these facilities. In 2005, Atlanta witnessed a tragedy in its courthouse that cost three lives and injured others. The same type of incident could occur in any of our courthouses at any moment.

The Sheriff's Department estimates that over 3275 people enter Norfolk's courthouses on an average day¹, excluding those who work in these buildings. Each person deserves to be safe while appearing in the halls of justice.

An additional concern is the safety of the public records. Case files, deeds, wills, marriage records, adoption records, recent judgments and financial statements – these are only a few of the many types of important documents retained in the circuit court-house. Similarly, metal cabinets containing thousands of civil and criminal case files line the public hallways of the General District Court's facility. Indeed, in many aspects the heritage of our city and its families is documented in these court records. If these records were destroyed, economic havoc might well erupt. It is significant that each of the studies noted that the existing filing and administrative spaces impede the effective operation of each court.

We understand that the responsibility for courthouse security in an operational sense rests jointly with the Sheriff and Chief Judges.² It is equally clear that the City shares this burden to the degree that it must provide courthouse facilities that are adequate and safe for the public.³ We appreciate the City's cooperation thus far. However, consistent with our responsibility we must insist that definite decisions be reached in the immediate future. The public safety is not served by continued indecision.

United States Attorney
Eastern District of Virginia

Chuck Rosenberg was appointed by Attorney General Alberto Gonzales in March 2006 to serve as the United States Attorney for the Eastern District of Virginia. He was subsequently nominated to that position by

President George Bush and confirmed by the United States Senate, unanimously, on June 13, 2006.

As the chief federal law enforcement officer for the District, which includes offices in Alexandria, Newport News, Norfolk and Richmond, Mr. Rosenberg supervises the prosecution of all federal crimes, and the litigation of all civil matters in which the federal government has an interest.

Mr. Rosenberg has spent most of his professional career in public service. From June 2005 until March 2006, he served as the United States Attorney for the Southern District of Texas. Prior to that, he served in several senior posts at the Department of Justice where his work focused on counterterrorism, counterintelligence, and national security matters, including as: Chief of Staff to Deputy Attorney General James B. Comey, Counselor to Attorney Gen

eral John Ashcroft; and, before that, as Counsel to FBI Director Robert S. Mueller, III.

Before joining the FBI, Mr. Rosenberg was an Assistant United States Attorney in the Eastern District of Virginia, in Norfolk and, subsequently, in Alexandria. There he prosecuted financial fraud crimes, violent crimes, and espionage cases. During the last two years of his tenure as a federal prosecutor in Alexandria, Mr. Rosenberg supervised that office's Major Crimes Unit - the unit that prosecuted numerous prominent spy cases. While in private practice with the law firm of Hunton & Williams, Mr. Rosenberg served as an NBC legal analyst, appearing frequently on television.

He is a graduate of Tufts University (B.A.), Harvard University (M.P.P) and the University of Virginia (J.D.).

Karen A. Gould was installed as the Virginia State Bar's sixty-eighth president in Virginia Beach in June 2005. She succeeded Phillip V. Anderson of Roanoke as leader of the 39,000-lawyer state bar.

Gould is a longtime volunteer in the bar's lawyer discipline system. She was chair of the Disciplinary Board, which adjudicates the most serious allegations of lawyer misconduct and served on the district disciplinary committee that hears cases in Richmond. Gould has served on VSB Council since 2000, and on the Executive Committee since 2002. She has been chair of the VSB's Budget and Finance Committee, and the Mandatory Continuing Legal Education Board.

Among Gould's biggest challenges is being the ambassador for an anticipated increase in bar dues which most likely will occur on the watch of Gould's successor, NPBA past president Howard W. Martin Jr. Preparation for the increase has begun, and explaining it is part of Gould's job as she travels to different regions of the state.

Items Gould listed on her to-do list when she took office included:

- the search for a successor to Thomas A. Edmonds, the bar's executive director, who will retire in 2007. She hopes to present a name to the VSB Council next June.
- Supporting recently launched bar projects—including the Chief Justice's initiatives on indigent defense, involuntary commitment of the mentally ill, and educational support for solo and small firm lawyers.
- Urging the General Assembly to observe the constitutional separation of powers as it elects and reelects judges.

- Improving the VSB's relationship with the General Assembly and the Supreme Court.
- Overseeing a new task force that will look into ways to better protect clients from lawver dishonesty.
- Steering the bar's decisions on future office space as the lease on its quarters in Richmond expires.

As a veteran volunteer in the disciplinary system, Gould is concerned that the VSB process is sometimes criticized for being unfair to solo and small-firm practitioners.

"If someone were to do a study of the cases brought before the Disciplinary Board, I think those misconceptions would be dispelled," she said. The cases brought before the Disciplinary Board are very serious, and the board considers each case with due deliberation.

Gould, born in Cleveland and raised in Richmond from the age of six, began her legal career as a law clerk for U.S. District Judge Glen Williams of Abingdon before joining the Virginia Attorney General's Office in 1980. She entered private practice in 1984. She is now with the firm of McSweeney, Crump, Childress & Gould, P.C. in Richmond.

Gould concentrates in the areas of professional liability defense, workers' compensation defense, and employment law. She also represents health care professionals before the health regulatory boards. She has defended obstetrician-gynecologists, emergency department physicians, general and vascular surgeons, plastic surgeons, orthopedic surgeons, and neurosurgeons. She has also represented hospitals, nursing homes and their employees in a wide variety

of claims covering all aspects of the care rendered to patients, and she has defended these facilities in employment-related matters and workers' compensation claims. She has also defended lawyers in legal malpractice matters.

She is married to Malcolm Rudolph "Rudy" West, a lawyer and corporate secretary for the New Market Corporation and they have a daughter, Elizabeth, who attends the University of the South in Sewanee. In her free time, Gould enjoys her three Welsh Corgis and, until recently, a horse. "For me, owning a horse meant that I could know what to expect from my beast. I hate fear of the unknown. I try to control my environment at all times," she said. With the horse gone, she took up running. "Running gives me time to think and provides me with a sense of accomplishment," she said.

Gould is a serious reader who finds time for a book club with law partners and other members of the Richmond legal community. She frequently reads books on her Palm Pilot. Recent titles she has taken on are Truman, by David McCullough; Love and Hate in Jamestown, by David Price; The Island in the Center of the World, by Russell Shorto (about the history of Manhattan); and Team of Rivals, by Doris Kearns Goodwin (about Abraham Lincoln and his Cabinet). Team of Rivals helped Gould focus on the qualities of leadership as she prepared to step into the VSB presidency, she said. "The leaders I have most admired are the ones who put aside their personal agendas and provide an opportunity for differing views to be voiced," Gould said. "They lead, rather than dictate".

Legal Aid Launches 40th Anniversary Campaign

The Legal Aid Society of Eastern Virginia, its Board of Directors, Staff, and Anniversary Campaign Committee, would like to express appreciation to the Norfolk & Portsmouth Bar Association for your support as we launched our 40th Anniversary Campaign November 2, 2006. To date, the campaign has raised \$25,000 in donations and pledges. Howard W. Martin, Jr., of Crenshaw, Ware and Martin and Robert "Bob" Nusbaum, of Williams Mullen are honorary co-chairs of the campaign.

Bob Nusbaum, a staunch advocate of pro bono support for Legal Aid had this to say about the campaign, "The truth is most of us practice in an environment where legal aid applicants seldom find their way to our doors. Public appropriations for legal aid have been cut heavily. Legal Aid Society lawyers are terribly overburdened, and we are now being asked to step up to the plate."

In 1967, a committee of the Norfolk and Portsmouth Bar Association established the Tidewater Legal Aid Society, which was re-incorporated as the Legal Aid Society of Eastern Virginia. For nearly 40 years, Legal Aid has served as a safety net for poor citizens of Hampton Roads. Its mission is "to promote the equal application of Justice, to remove impediments to fairness for the low-income and vulnerable families of Eastern Virginia, and to work within the justice community to help individuals realize their basic human rights." What began with 3 attorneys providing services to residents of Portsmouth and Norfolk, is today an agency of 42 lawyers and support staff with offices in Norfolk, Virginia Beach, Hampton, Williamsburg, and on the Eastern Shore.

In 1980, the Society added a Senior Law Center, providing special expertise in areas of law most affecting seniors, such as wills, advance medical directives, predatory lending and social security. In 2005-2006, Legal Aid completed 6,500 cases and won awards in excess of \$5,000,000, which benefited some 17,000 low-income residents living within 125% of the federal poverty level.

The 40th Anniversary Campaign asks each law firm to make a contribution on behalf of its lawyers, to fulfill our *pro bono* obligation. Some firms contribute in the firm name; others ask individual attorneys to make personal contributions. Whichever method your firm adopts, we would appreciate your firm identifying a liaison with Legal Aid for support of the Campaign.

Our goal is to raise an average of \$100 per lawyer for the local work of Legal Aid. The 40th Anniversary Banquet will be held in October 2007 at the Portsmouth Renaissance Hotel. Message from the Young Lawyers' Section

These events continue to be well-attended and provide an outstanding opportunity for us to get to know our local judiciary in an informal setting.

Kelley, U.S. District Court Judge for the Eastern District of Virginia. That bit of housekeeping out of the way, I wanted to spend a few moments on the topic of mentoring. Law school teaches us many aspects of the practice of law, yet once we enter practice, most young lawyers can't help but feel that we have been set adrift in a raging sea without a paddle, compass, or light to show the way. A mentor can provide the advice, reassurance, and commiseration a young or new lawyer needs to get through these difficult times. I doubt any of our more seasoned and venerable members could say they got where they are without at least a few, and probably several, mentors.

Unfortunately, like so many other things, mentoring of young lawyers often falls by the wayside due to the pressures of schedules, deadlines, and client commitments (not to mention those billable hours). We should take a moment to remember that mentoring was once the sole path of entry into the profession. Prior to the installation in 1779 of George Wythe at the College of William & Mary as our nation's first Professor of Law, and the shift

to formal legal education that followed, one became a lawyer through apprenticeship to a practicing attorney under whom the apprentice would work and study (admittedly, often with a heavy emphasis on the former, as Thomas Jefferson himself was known to lament). Our profession is thus guided by a deeply-rooted tradition of mentoring in the education and development of young lawyers.

Hopefully, every young lawyer should be engaged in at least one mentoring relationship with his or her supervisor. Many firms also provide assigned mentors to young associates outside their primary practice group. However, there may be times when a lawyer could benefit immensely from the learned advice of a colleague outside of his or her organization. A young lawyer may not feel comfortable discussing issues such as job satisfaction, work-life balance, or career development with a senior attorney in their office. Also, an attorney may seek mentorship and advice from someone of the same background, gender, or ethnic group who is not represented in their firm or agency.

Along these lines, our Bar Association is available as a prime source of mentoring opportunities for young and more experienced attorneys alike. JDR COURT APPOINTMENT LIST TO RE-OPEN

The Judges of the Norfolk Juvenile and Domestic Relations District Court are reopening the Attorney Court Appointment List, effective March 1, 2007. All attorneys wishing to be added on the list must submit an application to the Clerk of Court, Debra A. Hill, at 800 E. City Hall Avenue, Norfolk, Virginia 23510 not later than January 31, 2007. Applications may be obtained in person from the Clerk's Office or by written request to the Clerk. Any attorney wishing to be considered for inclusion on the list must be willing and able to represent persons charged with criminal offenses and must be willing and able to serve as a guardian *ad litem*. The following criteria will be considered when evaluating each applicant:

- 1. Certification by the Virginia Indigent Defense Commission to represent persons charged with misdemeanor, felony and juvenile offenses.
- 2. Certification by the Supreme Court of Virginia as a Guardian *Ad Litem* for children.
- Inclusion on the Norfolk Circuit Court Appointed List and inclusion on the lists of other cities.
- 4. Record of past performance demonstrated as court appointed counsel on assigned duty days, including, but not limited to attendance and timeliness.
- 5. Willingness and ability to affirmatively pursue appeals at all levels.
- 6. Willingness and ability to follow the standards of performance for guardians *ad litem* as set forth in Rule 8:6 of the Rules of Court as promulgated by the Judicial Council of Virginia (Standards to Govern the Performance of Guardians *Ad Litem* for Children, effective September 1, 2003).
- 7. Years of trial experience.
- 8. Proximity of the attorney's office to the courthouse and availability/accessibility to clients.
- 9. Timely investigation of the case and trial preparation.
- 10. Willingness and ability to comply with the Code of Professional Responsibility.
- 11. Record of prior disciplinary action.
- 12. Any other relevant consideration.

COURTHOUSE CELL PHONE USE

Effective December 1, 2006, cellular phones will be prohibited beyond the security screening desks at all three Norfolk courthouses. This new policy is based entirely on courthouse security concerns. As the capabilities of cellular phones have increased. we believe they have come to present a safety and security risk. Officers of the court will be the only exceptions to this rule. Attorneys, police officers, and probation officers may be asked for proper identification in order to exercise the exemption. Citizens arriving at the screening desk with phones will be directed to nearby lockers. Security screeners will not be authorized to hold phones, or any other property, while citizens attend to matters in the courtrooms or clerks' offices.


