On December 5, 2018, hundreds of recent law school graduates gathered in Richmond for admission to the Supreme Court of Virginia. If you are one of these individuals, the YLS congratulates you on your accomplishment and welcomes you to the esteemed and collegial practice of law in Virginia. Beginning your legal career is an exciting adventure but will inevitably present unexpected challenges. Whether it be balancing a healthy lifestyle with billable hour requirements, having a judge let you know that you failed to follow a particularly unique local rule or discovering that red pens were

invented for supervising attorneys to edit briefs, the transition from law school to law practice can be humbling. While I certainly do not have all the answers, and still experience many of the same challenges I did when entering practice, I want to share a few tips that I have learned along the way:

Be On Time And Be Prepared

There are precious few things that are fully in your control when you enter the legal profession. Supervising attorneys will have a decided impact on your workload and schedule. However, punctuality and preparation are completely within your control and, in my opinion, are the two most essential attributes for a successful new lawyer. They are also the most readily apparent characteristics one can possess. As a new lawyer, you are establishing your reputation within the legal community from scratch. Being late or unprepared leaves a lasting, negative impression on judges, opposing counsel and clients. Alternatively, consistently demonstrating yourself as punctual and prepared garners a trustful respect from others, a trait essential to your budding reputation.

Don't Be Paralyzed By A Fear Of Failure

A healthy fear of failure is a tremendous motivator. It informs your work ethic and demands that you strive to achieve your clients' goals. However, never allow yourself to be paralyzed by the fear of failure. The practice of law is, by design, an adversarial system. If a mutually agreeable resolution cannot be reached to end a dispute, one party will eventually win and the other will lose. Whether it be suffering an unfavorable jury verdict or having a judge deny your motion, every lawyer experiences losses in her career. In fact, I have learned much more from my failures than successes. Do not allow a fear of failure to paralyze your action. Knowledgably identify the legal issues, meticulously do the necessary research, concisely draft the required pleadings and zealously present your case to the best of your ability. If you do these things, you will have served your client admirably, regardless of the outcome.

Build Relationships With Lawyers Outside Your Firm

In my eight years practicing law in Virginia, I have found that the majority of lawyers I've encountered are extremely willing to provide assistance or advice to me when called upon. Build relationships with other lawyers in our community and seek out those who are willing to share their experience with you. NPBA social events and CLEs are an excellent opportunity to meet experienced lawyers of the bench and bar. These relationships with lawyers outside your firm will serve you well throughout your career. Not only will they be a source of valuable advice and assistance, but they also can serve as beneficial referral partners. Additionally, having relationships with lawyers outside your firm allows you to candidly seek advice about many of the challenges new associates face like dealing with a difficult supervising attorney or considering new employment opportunities.

INTERVIEWS WITH THE BENCH: ADVICE AND INSIGHTS FROM LOCAL JUDGES

Featured Judge: The Honorable Mary Jane Hall, Judge, Norfolk Circuit Court



Judge Mary Jane Hall was appointed to the Norfolk Circuit Court on March 1, 2009. Prior to her appointment, she practiced with the Norfolk office of Kaufman & Canoles, P.C., handling civil and corporate litigation, insurance defense, and health care matters. She serves on a number of Supreme Court committees that work to oversee and improve various areas of law in Virginia, including Commissioners of Accounts, Domestic Violence, Judicial Canons, and Guardianship stakeholders; and she is a judicial member of the General Assembly's Virginia Alcohol Safety Action Program Commission. She graduated from the University of Maryland and the Georgetown University Law Center and came to Norfolk in 1984 to clerk for U.S. District Judge J. Calvitt Clarke. She lives in Norfolk with her husband John and their two Vizslas.

Q: What advice would you give to members of the local bar when practicing in your Court?

- A: 1. Introduce yourself to the Court. Simple introductions make help avoid confusion and streamline the docket.
- 2. Send a courtesy copy of any motions or memorandums to chambers if a hearing has been noticed and assigned to a particular judge.
- 3. Do not hand up an unfiled motion and brief during a hearing and expect it to be heard that day.
- 4. Engage in a good faith effort with opposing counsel to resolve matters before bringing them to the Court's attention. Our local rules require this good faith effort and certification.
- 5. Guard your reputation. Remember that this client and this case will conclude, but your reputation will last as long as you practice law. No case or client is worth

compromising your reputation.

Q: What makes you optimistic about the future of the practice of law?

A: The practice of law is much more inclusive now compared to when I first came into the practice. When I first started graduated law school, the bar was not very diverse, but I think we are moving in the right direction. There are also more areas of law focusing on social problems and that makes me optimistic and proud to think that my profession could be a key factor in creating positive social change.

Q: What have been the best tools throughout your career that have assisted you in the balancing of law and life?

A: I am a ruthless planner/scheduler. When my kids were young and the demands were high both personally and professionally, I had to find a way to make it all work and planning and scheduling was my remedy. Now, as a judge, I keep this habit and do my best to meticulously keep track of everything I have going on and sometimes that means I am in triage mode and other times I get to work on my rainy day projects.

Q: What is the most challenging aspect of serving as a judge on the Circuit Court bench?

A: As a judge, we are asked to address serious problems with limited tools at our disposal, which can be challenging when dealing with serious, systemic problems. Substance abuse, for example, is an area where there are not many resources or options at my disposal to address the underlying problem. This makes me wish I could do more for people that are in horrible places to give them a fighting chance and to feel good about their lives like everyone else.

PRO BONO OPPORTUNITIES WITH THE UNITED STATES DISTRICT COURT FOR THE EASTERN DISTRICT OF VIRGINIA

At times, the Judge assigned to a civil pro se case in our local Federal Courts may determine that the appointment of counsel would help to facilitate the administration of justice. In order to aid in the attorney search process when such circumstances arise, the Norfolk and Newport News Divisions of the United States District Court for the Eastern District of Virginia maintain a list of volunteer attorneys and/or law firms who may be willing to represent such plaintiffs, on a pro bono basis. The majority of cases requiring counsel will likely involve civil rights claims brought pursuant to 42 U.S.C. § 1983; however, representation may be needed in other types of civil cases.

When the Court determines that the appointment of counsel is necessary, the Court will reach out to an attorney or law firm contact from its list of volunteers, provide a summary of the factual allegations of the case, identify the involved parties, and allow the potential volunteer a reasonable amount of time to determine whether he or she is willing and able to provide representation.


