PRESIDENT'S MESSAGE

Virginia is home to many of this country's greatest public buildings. Jefferson's Rotunda and Lawn accommodate the needs of the persons using them with a graceful simplicity. Our State Capitol building, also a Jeffersonian design, reflects this same elegant simplicity. The lavish renovation it has recently received has only increased its luster.

As it is with these centers of learning and government, so it is with courthouses. The courthouse is more than the sum of its bricks and mortar—or, glass and steel—that comprise it. Courthouses are where a great deal of the public's business gets done. Each day, the courthouse is the place where the rule of law is made manifest to the public.

As such, a courthouse makes a prominent statement about the sort of people that have built it and that use it. A poor courthouse reflects poorly upon the public that constructs it because it reflects a low regard for the administration of justice. A great courthouse speaks to present and future generations loudly that the rule of law is held dear.

The courthouse is the personification of the public soul.

Norfolk, possessing a rich history, was where one of the early courthouses in the colonies was built. Norfolk's first courthouse, built in 1661 on Broad Creek, predates the founding of the Republic by over one hundred years.

The building that currently serves as the MacArthur Memorial served as Norfolk's courthouse during the second half of the 19th century and first half of the 20th. The construction of this courthouse heralded the emergence of Norfolk as a city from its previous incarnations of town and borough.

This former courthouse is a stately, yet familiar, building. According to the *Virginian-Pilot's* George Tucker in a 1997 column:

"The classical revival courthouse now serving as MacArthur's shrine was the architectural manifestation of Norfolk's new dignity when the Virginia General Assembly passed an act on Feb. 13, 1845, and changed the borough's status to that of a city. The imposing building that housed Norfolk's courts and civic offices for more than a century was first occupied on May 20, 1850".

It should not surprise many of you that my research failed to uncover a similar paean to Norfolk's current courthouse facility. It does not appear in *Virginia's Historic Courthouses*. It is an exemplar of lousy design. It is a utilitarian-looking building that lacks utility. It is unsafe. It is ugly. The problems with the current facility are legion, and the space I am allotted does not permit a full recitation here.

Suffice it to say that it is hard to imagine our current facility as Douglas MacArthur's final resting place.

Recently, the Norfolk City Council began the first steps toward the construction of a new court-

house facility to replace the 1960's era complex. This decision indicates that City Council recognizes the necessity of a new courthouse. Given the finite nature of the city's resources, and the cries from a vocal segment of the public seeking to make such resources more finite, this was not an easy decision.

Because the process of funding, designing and constructing the courthouse will be a long one, this decision deserves—indeed requires—the continuous support of the entire bar. Please take the time to make your support known publicly, whether by writing letters to the media or by thanking members of Council.

The courthouse that the public and the bar will have for the rest of our lives will be the product of this effort.

NPBA PRESENTED VSB AWARDS OF MERIT

NPBA received 2 Awards of Merit from the Virginia State Bar Conference of Local Bars at the VSB Annual Meeting in June. This marks the 22nd year of the Awards of Merit competition which recognizes outstanding projects conducted by local and specialty bars of all sizes, to encourage greater service to the public and the profession, and to give local bars the opportunity to learn from the programs of other bar associations.

Out of 26 awards statewide, NPBA received 2. Our winning projects were the record-setting and now statewide Legal Food Frenzy and the activities of the NPBA Foundation.

Virginia State Bar Executive Director/Chief Operating Officer

The Virginia State Bar (VSB), an agency of the Supreme Court of Virginia, invites applications for the position of Executive Director/COO.

The VSB is governed by a 12 member executive committee and a council of 75 members, who are elected or appointed from every judicial circuit in the state.

The Executive Director is responsible for the day to day operations of the bar, manages the budget, supervises the senior staff, assists the officers in their roles as spokespersons for the VSB and performs in that role as directed or as circumstances require with the judicial branch, the legislature, the executive branch, other bar organizations, the members and other outside entities.

- License to practice law, and if not already admitted in Virginia, eligibility to be so admitted.
- Significant experience in managing a multi-function organization; the ability to communicate clearly and persuasively both orally and in writing; budget and financial management skills.
- Ability to work with diverse groups building consensus and respectful relationships, both within and external to the organization.
- Significant experience working with law-related organizations and/or professional associations is a plus.

Your clients will *like* this new tax law. No kidding.

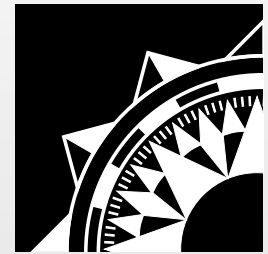

Norfolk Sheriff Robert J. McCabe seeks an attorney licensed in the Commonwealth to serve as in-house counsel to the Norfolk Sheriff's Office. Duties include:

- Provide comprehensive employment law advice regarding a staff of approximately 500, including discipline, hiring, termination, and supervision actions, workers compensation, FMLA, and FLSA; coordinate with all necessary parties to complete appeals of unemployment decisions.
- Prepare and review contracts for services, as well as ordinances for city funding.
