they don't already know. So, I've tried to write pieces that are interesting and, hopefully, make people think. I have been gratified that some of you take the time to actually read them.

I tuned into a PBS program this morning where Warren Buffett and Bill Gates were speaking to an audience of college students. They defined success as being properly measured by the degree that family and friends loved and cared for them, not whether they were the richest people in the world. (Actually, Mr. Buffett said this; Mr. Gates simply smiled that goofy smile of his.). Mr. Buffett indicated that persons whose lives positively impact others could be fairly called successful. By contrast, he indicated that many of his acquaintances, including members of the Fortune 400's richest persons in the world, have immense wealth and have schools, parks and libraries named after them, but lack true success because they lack persons that care about them. Success depends in large part in how it's defined. I tend to agree with Mr. Buffett.

I strayed from my maxim in paragraph six. Sorry.

As President of the Association this past year, I have tried to guide the Association to have a positive impact upon the members and our profession. Whether this has been successful, I leave to you. I am encouraged by the enthusiasm of the members that believe in the value of voluntary bar associations such as ours and demonstrate this by supporting our programs. In the future, I believe, the Association will need to become more of an advocate for the profession in matters of public concern.

Thank you for your attention. As I look in my rear-view mirror as I pass through Williamsburg, my worry about waking my boys is, apparently, unfounded.

Hits at the Park, Harbor Park Speaker: Howard W. Martin, Jr. President, Virginia State Bar

Howard Martin came to the position of VSB President with extensive bar association leadership experience. He began with the Virginia State Bar through its disciplinary system, which he considers the bar's primary responsibility. "The bar has a lot of other roles, but the regulatory function is the one that is first and foremost." Martin has represented his home circuit on VSB Council, and served on its executive committee since 2003.

He is a past president and now fellow of The Virginia Law Foundation, and a for-mer chair of the VSB Budget and Finance Committee.

He was secretary of the Virginia Bar Association and a member of its executive committee in the late 1980s and early 1990s. That duty and his friendship with leaders of other statewide bar associations have attuned him to the missions and challenges of the commonwealth's voluntary bars. Martin served as President of the NPBA in 1997-98

and was renowned for his taste in barbecue, as recounted in his President's Message in the Bar Bulletin.

Martin is a lifelong resident of Hampton Roads, with the exception of college (W&L and the University Of Virginia School Of Law) and a four-year stint in the Navy during Vietnam (two years as a line officer on a fleet oiler, then two years of shore duty in Charleston, South Carolina, in the Judge Advocate General's Corps). He and his wife, Heather, have three children and two grandchildren.

# TUESDAY, APRIL 8, 2008

# KEYNOTE SPEAKER: VIRGINIA SUPREME COURT JUSTICE DONALD W. LEMONS

Please mark April 8, 2008 on your calendar for this year's Bench Bar Conference. This year's conference will be held at the Norfolk Waterside Marriott in downtown and our featured luncheon speaker will be the Justice Donald W. Lemons of the Supreme Court of Virginia.

Because civility in practice has become a topic of particular interest among practitioners and judges, we have decided to make it the focus of our first general session. That session will feature insights by Judge Charles E. Poston, Judge Walter D. Kelley, Jr., and Judge Mark S. Davis. The judges will give us their views (and perhaps a few war stories) concerning how law should and should not be practiced and how to avoid the problems that they see from the bench.

Our breakout sessions include a variety of topics from the Fair Debt Collection Practices Act featuring Magistrate Judge Dennis W. Dohnal from Richmond, Len Bennett and John C. Lynch, to developments in criminal practice featuring Jack Doyle and Sherri Carr, to issues in employment law, including the Fair Labor Standards Act featuring Judge Rebecca Beach Smith, Sam Webster, Jamie Shoemaker and David Burton.

Our final general session will be a review of the significant statutory changes and judicial opinions during the past year and will feature Judge Everett A. Martin, Jr., the Honorable Sal Iaquinto and Steve L. Emmert.

This year's Conference should have something for everyone and will give you the opportunity to raise the issues that concern you with respect to practice in local courts. We hope to see you there!



**Justice Lemons** 

Virginia Supreme Court Justice Donald W. Lemons was born in Washington, D.C. in 1949. He received a B.A. from the Uni-

versity of Virginia in 1970, and a J.D. from the University of Virginia School of Law in 1976. From 1976 until 1978, he served as Assistant Dean and Assistant Professor of Law at the University of Virginia School of Law. Thereafter, he entered the private practice of the law in Richmond.

He served as a Substitute Judge for the General District Courts and Juvenile and Domestic Relations Courts from 1994 to 1995 and served as a Commissioner in Chancery for the Henrico County Circuit Court from 1988 to 1995. In 1995, he was appointed a Judge of the Circuit Court of the City of Richmond, where he served until 1998 when he was elected by the General Assembly to serve as a Judge of the Court of Appeals of Virginia. He took the oath of office as Justice of the Supreme Court of Virginia on March 16, 2000. Justice Lemons is also the John Marshall Professor of Judicial Studies at the University of Richmond School of Law.

Among other activities, Justice Lemons serves on the Board of Trustees of the American Inns of Court and was a member of the Jamestown 2007 Steering Committee.



## Marketing Planning: Good + Action > Waiting 4 Perfect

A good battle plan that you act on today can be better than a perfect one tomorrow. - Gen George S. Patton

Although Patton wasn't talking about legal marketing, a well thought out plan is key to developing successful marketing efforts. In most law firms, there are an abundance of officers – each with his or her idea of the perfect "battle plan" for conquering advertising and marketing. Before investing resources in advertising wars, however, it's important that everyone read from the same map — agreeing on the starting point and the end target. Otherwise, the battle will certainly be lost to funding, political and morale struggles.

Creating a "good battle plan" is simple and takes little time and effort from the attorneys. But, the "leaders" do have to lead by sharing their thoughts and ideas, *in writing*. A Communications Work Plan (CWP) is a simple document, which helps to ensure all the parties concerned are on the same wavelength. Each attorney involved in the project should complete this informal worksheet, which is an easy brainstorming exercise. Then, the comments are combined, shared, tweaked and agreed upon. The road map to a marketing plan is established.

Technically, the CWP can be used in place of the "perfect" marketing plan. As long as there are clear goals of what's being marketed, what the assignment is and when it is to be complete... as well as a budget. Ideally, it is used for creative development as well as the cornerstone of building an integrated marketing effort that includes advertising, public relations, etc.

The key questions to answer in a Communications Work Plan are (answers can be bulleted, sentences, slang, etc.): PROJECT:

- 1. What are we marketing?
- 2. What is our assignment?

#### INPUT:

- 1. Who is the target audience?
  - External
  - Internal
- 2. What do they think or do?
- 3. What do we want them to think or
- 4. What argument will convince our target to think/do what we want them to?
- 5. What information will support the argument?
- 6. What competitive considerations should be reflected in the argument or message?

- 7. What tone or manner should be reflected in the argument or message?
- 8. What are the mandatory components of the execution, if any?
- 9. What is the budget for the project?
- 10. What timing (scheduling) considerations must be considered?
- 11. What are the geographic considerations?

Remember, ACTION on a good plan today is better than growing stagnant waiting for the perfect plan tomorrow.
