President's Message

Every year the Conference of Local Bar Associations sponsors a Bar Leaders Institute at the University of Richmond School of Law. Participation is free, and it draws Bar leaders from across the Commonwealth. I had the privilege of attending this year, along with two other members of our Executive Committee, Mary Morgan and Kelly St. Clair. The first half of the program focused on the importance of a strategic plan for all Bar associations as well as a periodic review of the strategic plan to make certain that it remains relevant, and that the association is meeting the needs of its members. As it turns out, our President, Chip Beaman, is ahead of the game. In his very first President's Message, Chip wrote:

Planning for the future. For any organization, it is critically important that there be a carefully constructed roadmap to help guide its future course. This is particularly true in times of economic distress and uncertainty. The NPBA has enjoyed remarkable success over the years due to the loyalty and dedication of its members and staff. And although we do have in place a mission statement, we do not have a strategic plan that sets forth in sufficient detail our short term and long term goals and how we intend to achieve them. Dave Lannetti recognized this deficiency and began the process of addressing it during his term as President. Jeff Stredler in turn continued the process. It is my hope that by the end of the year we will have a strategic plan in place, ready to be implemented, that will prove to be an effective guide for the Association well into the future.

At the start of his term in office Chip asked former Bar President Dave Lannetti to chair the Strategic Planning Committee, whose task was to review the NPBA mission statement, to make any necessary revisions, and to develop a strategic plan for the Association. Chip included on the committee lawyers of all ages, from large and small firms as well as solo practitioners. The Committee also had representatives from local law schools as well as the bench.

Before tackling the strategic plan, the Committee concluded that it was important to first articulate the Association's mission:

The mission of the Norfolk Portsmouth Bar Association is to serve our members, the legal profession, the justice system, and the community at large through: education; advocacy on behalf of the legal profession and the judiciary; and programs that help meet the legal needs of the community.

In essence, the mission of the Association is to serve. The Association has an obligation to serve not only its members, but through its members to serve the legal profession, the justice system

and our community. This conclusion rests on the NPBA's aspiration to be the preeminent legal professional association in Hampton Roads. The Committee concluded that, by virtue of our status as lawyers and officers of the court, we not only should, but have an *obligation* to, serve the profession, the justice system and our community. In short, the obligation to serve has less to do with the nature of our Association and more to do with the status of our members as legal professionals.

Once the Committee identified and articulated the mission of the Association, it turned to the various methods by which the Association could implement its mission. Those of you who are active in the Association know that NPBA emphasizes education. Its leaders work to provide meaningful opportunities to attend and participate in continuing legal education, including the "season ticket" package which allows members unlimited access to any CLE sponsored by the Association. Indeed, the CLE Committee is perhaps the most active in the Association, working to provide both general programs useful to all members as well as programs specifically tailored to individual practice areas. In addition, the Association sponsors the annual Bench Bar Conference, providing more continuing legal education as well as an opportunity to interact with our judges, both state and federal. Fourteen judges attended this year's conference, and ten participated as speakers.

Another method by which the Bar Association serves is by advocating on behalf of the legal profession. Keeping in mind that its goal is to serve its membership, what is the appropriate "litmus test" for determining when a "cause" improves the profession, and thus merits the Association's advocacy? Clearly it would not advocate for a policy or rule that would favor plaintiffs or prosecutors over defendants or vice versa. But there are some causes the Association can comfortably back as having the support of virtually all of its members. For example, the Association has, through its Courts of Justice Committee under Don Schultz's leadership, advocated for and participated in the design of the new courthouse complex. No one could credibly argue that a new courthouse would not be in the best interest of our profession or the legal system. The Strategic Planning Committee concluded that the advocacy should extend to issues on behalf of judges and/or the judicial system as a whole, under appropriate circumstances. While the Committee was not so naïve as to think that the Association can inject itself into the political process inherent in selecting judges, it can certainly play a role in providing to legislators input with regard to the qualifications, including experience, of various candidates. In addition, the Committee agreed that it is entirely appropriate for the Association to advocate for an independent judiciary.

Finally, the Strategic Planning Committee concluded that the Association could serve its members by providing opportunities to serve in the community. Of course, the NPBA has been associated with the Legal Food Frenzy for more than 20 years; in fact, the Food Frenzy was the brainchild of Association members Bill Nusbaum and Peter Huber. The Association provides opportunities to participate in local high schools through its Mock Trial Project and Mentoring Program. In addition, attorneys can participate in the "ForKids" Program, sponsored by the Young Lawyers Section. And the Association is looking to expand these opportunities, as one of its long range goals is to provide "meaningful community involvement opportunities in which members are encouraged to participate."

If you have not already done so, please visit the NPBA website where you can find a link to the full strategic plan, which lists the Association's core values as well as its long range goals. Remember, this is your bar association, and its primary mission is to serve. To that end, we welcome input from all of our members with regard to the strategic plan which, to be effective, must always be a work in progress.

New NPBA Strategic Plan

After approximately six months of hard work, the *ad hoc* NPBA Strategic Planning Committee (appointed by NPBA President Chip Beaman and comprised of a diverse cross-section of NPBA's membership) presented a draft NPBA Strategic Plan to the Executive Committee for approval. The Strategic Planning Committee's task was to identify and articulate a vision, a mission statement, core values, and long range goals for the Association. Of note, the aim was not to change the current direction of NPBA, but rather to create a document on which the Association and its leadership could focus as the NPBA President and Executive

Committee develop goals each year. The Strategic Plan will allow the Association to identify where it wants to be three to five years from now and how to get there.

The Executive Committee approved the draft Strategic Plan, which now is available on the Association's website (www.norfolkandportsmouthbar.org). According to the Plan, Norfolk & Portsmouth Bar Association's vision is "to be the pre-eminent legal professional association in Hampton Roads," and its mission is "to serve our members, the legal profession, the justice system, and the community at large through: education; advocacy

on behalf of the legal profession and the judiciary; and programs that help meet the legal needs of the community." Look for your Association to initiate a plan of action, incorporating its core values and consistent with its mission and long range goals, that best allocates its resources—including you, the Association membership—as it strives to make its vision a reality. Incorporated properly, a successful strategic plan is best exemplified by what motivational speaker Joel Barker once observed: "Vision without action is merely a dream. Action without vision just passes the time. But vision with action can change the world."

Federal Court Pro Bono Counsel Program

The Judges of the Norfolk and Newport News Divisions of the United States District Court for the Eastern District of Virginia are pleased to announce the creation of a Pro Bono Counsel Program in conjunction with the Office of the Federal Public Defender ("FPD"). The Pro Bono Counsel Program will be a partnership between the FPD and private law firms/practitioners through which attorneys act as pro bono co-counsel under the supervision of one or more Assistant Federal Public Defenders in federal court cases. The pro bono cocounsel's responsibilities may include legal research and writing, drafting pleadings, meeting with clients, participating in court proceedings, and appellate work.

Under the partnership, firms may participate by identifying one or more attorneys who are interested in committing the time and energy necessary to act as *pro bono* cocounsel on indigent criminal cases assigned to the FPD. The partnership is open to any attorney who has been admitted to practice before the United States District Court for the Eastern District of Virginia.

The Pro Bono Counsel Program serves the mission of the FPD and the Court in a

number of important ways. First, the FPD and its clients benefit from the assistance firm attorneys can provide, especially in complex cases or cases that result in a jury trial. Second, firm attorneys benefit from the experience and training they receive by working with and under the supervision of experienced federal court practitioners. Third, the Court benefits from having experienced attorneys practice before it, especially if some of these lawyers later join the Criminal Justice Act ("CJA") Panel, thereby being eligible for direct court appointments in criminal cases. Finally, the program encourages pro bono contributions by law firms/practitioners to the defense of the indigent in federal court.

The Pro Bono Counsel Program is endorsed by the Judges of the United States District Court for the Eastern District of Virginia. For additional information about the program, and for enrollment procedures, please access the Federal Public Defender website at www.vaefpd.org.


