PRESIDENT'S MESSAGE



Robert V. Timms, Jr.

I would like to address two matters. The first is the creation of a new bar association committee. The second concerns a situation I am currently experiencing, which I thought would helpful to all members of the bar association.

The Honorable David W. Lannetti, Judge of the Norfolk Circuit Court, approached the Association concerning the creation of a Bench Bar Relations Committee. While the Executive Committee is working on specific goals and guidelines for the committee, it is supportive of its creation and we expect to approve it at our next meeting.

The committee is expected to consist of one to two judges each from the Circuit, General District and Juvenile and Domestic Relations District Courts. It is also expected to have six to nine attorneys, who practice

primarily before each respective court. The committee will act as a liaison on issues of shared concern such as pro bono (what types of cases the judges are seeing that are in critical need of support), practice specific issues (substantive and procedural), professionalism, and other areas of common concern.

The new committee will not supplant any other association committee or their respective activities. It will serve as a resource for other committees interacting with the Court such as the Bench Bar Committee, the Pro Bono Committee, the CLE Committee and the Young Lawyers Section.

We will be sending out an email request to our members in the near future to see who may be interested in serving on this committee. This committee is a great opportunity for our association to strengthen one of the purposes for which it was created and to create an opportunity for greater member participation.

The second matter I wanted to address is the need for all of our members to plan for unforeseen medical issues. In the last part of September, I fell and ruptured my patella tendon. I required surgery to correct the condition. Having never previously experienced a sudden disabling event, I found myself scrambling to find assistance in covering the matters I was working on prior to my accident. Unlike a planned vacation, I did not schedule my appointments around the time I would be out of the office, nor did I have time to find someone to cover my ongoing matters. Luckily, I have enough partners and support staff to assist me through this period. However, there are other matters we must plan to deal with outside of our clients and their legal matters. The biggest concern for me is that I cannot bend my knee for six weeks, which prohibits me from driving. It also means that, if I have a meeting out of the office or a lunch I have to attend, I need to plan ahead of time to figure out how I will get to the meeting or lunch and how and where I will sit. In other words, I am limited as to what meeting or lunches I can attend. Luckily, with the arrival of Uber and

Lyft, I have ways to get around town. These services are very useful, but they do require you to add additional time in your schedule to accommodate the arrival time of the drivers.

I urge you to set up a plan with your staff now to deal with unforeseen emergencies. I suggest you work out a list of attorneys who your staff can call to cover your cases in the event you are incapacitated. I was fortunate in that I was able to make phone calls after my accident and after my surgery. However, if I was unable to communicate with my office, then my staff would not have had an action plan to initiate to handle my active files. I urge you to plan now for unforeseen emergencies.

THE VALUE OF POSITIVE BENCH-BAR RELATIONS

Positive bench-bar relations support and improve the administration of justice, increase professionalism throughout the legal system, and enhance service to the community. Facilitating open communication and a certain degree of familiarity between judges and attorneys also makes the practice of law more enjoyable from the perspectives of both the judiciary and legal professionals. Creating opportunities for the bench and the bar to interact therefore is a worthy goal, and one that the Norfolk & Portsmouth Bar Association (the "NPBA") fully embraces.

The deep-rooted relationship between the bench and the bar stems back to the NPBA's inception more than a century ago. The original charter from the General Assembly of Virginia, which was approved March 5, 1900, committed the NPBA and its members to "cultivating and advancing the science of jurisprudence, promoting reform in the law and in judicial procedure, facilitating the administration of justice and upholding and elevating the standard of honor, integrity and courtesy in the legal profession." (emphasis added). True to this purpose, the NPBA and its leadership over time established specific programs designed to strengthen benchbar relations.

The NPBA is recognized throughout the Commonwealth for being on the forefront of developing and maintaining programs and events that bring the bench and the bar together. Judges traditionally have participated in the NPBA's continuing legal education ("CLE") programs and monthly speaker luncheons. In 1999, the NPBA established an annual Bench Bar Conference, where practitioners and judges gather to discuss relevant legal issues. CLEs featuring judicial presenters, including specialized breakout sessions, create a unique setting for judges to exchange ideas with attorneys regarding substantive and procedural legal topics. The event also includes a luncheon with a prominent speaker relevant to the legal community. In 2001, the Young Lawyers' Section of the NPBA introduced an annual New Lawyers' Reception, hosted by a Norfolk Circuit Court judge at his or her

home. Initially envisioned as an event for new attorneys to meet local judges in an informal setting, it has since been renamed the annual Fall Reception and has been expanded to include all NPBA members. In 2004, the Young Lawyers' Section initiated a Breakfast with the Bench series, where several times a year a local judge is invited to breakfast to socialize and deliver informal comments typically aimed at new attorneys. The NPBA also periodically sponsors an "Introduction to the Norfolk Courts" CLE, which incorporates judicial speakers, to familiarize new attorneys with local judicial procedures. These programs contribute to continued, strong relations between the bench and the bar and, together, the regular interactions and resultant collaborations positively shape the local legal environment.

The benefits of strong bench-bar relations should not be underestimated. By engaging with judges in social settings, attorneys develop a sense of professional familiarity that reduces stress in the courtroom and enhances effective advocacy. Additionally, attorneys gain a better appreciation for effective practices and judicial expectations regarding professionalism. Judges also benefit by using these interactions as conduits to communicate their preferences regarding courtroom procedures and behaviors, thereby promoting efficiency while adhering to the rule of law. By using social interactions to manage expectations in the courtroom, everyone is better off. The bench and bar can also work together in their service to the community by developing best practices to enhance and streamline court-appointed and pro bono services for those who cannot afford legal representation.

The benefits of a positive bench-bar relationship go beyond direct interactions between judges and attorneys. Area legislators often ask the NPBA to interview potential judicial candidates and recommend which ones the Association believes are qualified to be appointed judges. Similarly, the Chief Judge of the Norfolk Circuit Court typically requests that the NPBA interview potential district court substitute judges and provide a list of qualified candidates for final selection. Judges also

look to local bar associations to comment on matters related to judicial independence and other justice-related issues, including the need for new courthouse facilities.

The NPBA has sponsored wonderful programs over the years that have fostered the administration of justice, improved professionalism, and encouraged community service. These programs also contributed and continue to contribute—to a robust bond between local judges and attorneys. Looking ahead, there are additional ways to enhance bench-bar relations. After the completion of Phase II of the City of Norfolk Courthouse, the NPBA Office will be located within the impressive judicial complex. The continuous, close proximity of the bench and bar will present opportunities for further growth and additional partnerships. Additionally, it is noteworthy that the NPBA currently does not have a committee to address issues that affect both judges and attorneys, something incorporated into many local and statewide bar associations. The formation of such a committee could serve as a resource to the NPBA's Bench-Bar Committee, CLE Committee, and Young Lawyers' Section for established judicial programs. Such a committee could also explore new ways for judges and attorneys to collaborate with and support each other. An NPBA Bench-Bar Relations Committee almost certainly would result in a great bench-bar relationship becoming even stronger.


